- I understand tuition and other fees are necessary for Danville Christian Academy to successfully fulfill its God-led mission. I commit myself to promptly meeting my financial obligations in accordance with Biblical stewardship. I also understand and agree with the following tuition policy.
- I understand that my child is **NOT** fully enrolled until both the enrollment and instructional fees are paid.
- I understand that the enrollment and instructional fees are non-refundable.
- I understand that withdraws are subject to the following financial obligations:
  - I understand that if I withdraw my student(s) any time after June 1<sup>st</sup>, I am required to pay additional tuition of 25% of the annual tuition or the remaining tuition for the year whichever is less.
  - Requests for exceptions must be forwarded to the Headmaster in writing, and will only be considered in extreme circumstances.
- I understand that if I enroll/ reenroll prior to June 1<sup>st</sup>, I may opt to take the 12 month payment plan. Enrollment after June 1<sup>st</sup> will require a choice between the 10- month option, the one pay option or the two pay options.
- I understand that all 10-month and twelve –month payments **will be** made through automatic bank draft. One pay and two pay options will be made either by automatic bank draft, personal check, money order, or cash.
- I understand that the costs involved in operating the Danville Christian Academy significantly exceed the amount families are charged in tuition and fees. Therefore, I agree to do my fair share to bridge the gap between costs and tuition. I pledge to prayerfully consider supporting the ministry of the Danville Christian Academy. I understand that this can be met through voluntary tax-deductible gifts and/or participation in the fundraising programs of the school.
- I understand that my child's records will not be released to another school or individual if I am delinquent in my tuition payments or any other DCA account.
- I understand that there are additional miscellaneous fees throughout the school year that include, but are not limited to fees for lunches, snacks and/or drinks, school pictures, yearbooks, participation in sports, participation in various academic or liberal art activities and field trips.
- I agree to update my child's medical records with the DCA office as required.
- I understand that my child participates in outside activities including playing on the playground and/or parking lot areas.
- I understand that Danville Christian Academy admits students of any race, color, national or ethnic origin to all rights, privileges, programs, and activities generally made available to students of this school. Danville Christian Academy does not discriminate on the basis of race, color, national or ethnic origin in the administration of its educational policies, admission policy, scholarship program, athletic and other school-administered programs. DCA reserves the right to make admission decisions for new students based on the religious beliefs of the student and / or their family.

- I understand and do support Danville Christian Academy's Statement of Faith as follows:

  - We believe there is one God eternally existent in three persons- Father, Son and Holy Spirit.
